

Below are the motions received by the committee to be discussed at the 2025 AGM on Wednesday 19th November 2025.

Motion 1 – Proposed by Darren White seconded by Lachlan Hunter
Re: Association singles & doubles events

I would like to move a motion that the west coast singles and doubles are only open to west coast number one association players

Motion 2 – Proposed by Darren White seconded by Lachlan Hunter
Re: Association singles & doubles events

I would like to move a motion that all single and doubles are nominated and paid online at least 5 days before the event

Motion 3 – Proposed by Brendan Andrews seconded by Nathan Robertson
Re: Change of time to Delegate's Meeting

I would like to put a Motion forward that Delegate meetings now be brought forward to 7pm start time.

Motion 4 – Proposed by Lachlan Hunter seconded by Darren White
Re: Amendment to our playing rules section 12.3.

The Team finishing on top of the ladder at the end of the qualifying (Home & Away) rounds is the Divisional Winner (Minor Premiers). The top four teams in every Division qualify for the finals to decide the Premiers and Runners-up. Format is in line with the Page System; Week 1 Semi Finals - Second Semi Final (Double chance) one versus two. First Semi Final three versus four. Winner of one and two goes straight into the Grand Final. Loser of three versus four drops out. Week 2 Preliminary Finals - Loser of one versus two plays the winner of three versus four from the week 1 Semi Finals. Loser of this game drops out. Week 3 Grand Finals Winner of the Preliminary Final versus winner of one versus two from the week 1 Second Semi Final. *In the event that a division is comprised of less than 6 teams, then the top 2 teams go straight through to the grand final with no other finals to be played. *

Re: Remove Section 11 Point F.

Honorariums may only be paid to WCMDA appointed committee persons. 1) All honorariums must be reviewed at the AGM. 2) Honorariums are paid in connection with the WCMDA business. They are paid in recognition of the services provided to the WCMDA. 3) These payments do not apply at market rates. *We should (as an association) should not payout honorariums. Like most other associations we should reimburse expenses made by committee members after receiving a receipt to confirm expenses. These can still be queried by members of the committee to ensure against false payments.*
